# Terms and Reference For Consulting Service Selection of Program Specialist (Public Workfare) for SMoDMRPA Project

The World Bank has approved the Safety Net Systems for the Poorest Additional Financing project (SNSP AF) in March 2020. It builds on the earlier SNSP project (approved in 2013) that aimed to provide support for improved implementation of the safety nets under the Department of Disaster Management, Ministry of Disaster Management Releif (MoDMR), with the objective of improving the equity, efficiency and transparency of five safety net program geared towards the poorest. This will allow the DDM/MoDMR to leverage good global practices in the areas of building targeting, program administration and M&E systems and lead these five safety net programs along an incremental reform path to better serve the needs of the poor.

In this project, EGPP component of the SNSP AF project. This component (Component 4) provides benefits to the poor and vulnerable through Public Works in exchange for wages. The EGPP is currently being implemented country-wide with an end goal of 950,000 beneficiaries across 63 districts. The recently approved SNSP AF contains within it the EGPP+ component that increases the breadth and depth of EGPP coverage in the Cox's Bazaar district by 40,000 beneficiaries and improves shock responsiveness through additional top-up payments and alternative work modalities (further details are available in the subsequent sections and in the World Bank Project Appraisal Document).

The Department of Disaster Management (DDM) is seeking to secure the services of a Consultant Firm (hereto referred to as the "Consultant") to carry out a series of third-party assessments (spotchecks and evaluation) of the EGPP+ component of the SNSP AF project for a period of 23 months. Such third parties serve as an independent feedback mechanism of program inputs, outputs and performance and is a key component of effective program implementation. Incorporating such assessments on a regular and timely basis plays a major role in ensuring the integrity of the public financial management and sustain a robust accountability framework by enhancing the flow of information to the citizens and feedback from citizens to the decision-makers.
